COVID-19 AND ITS IMPACT ON STOCK MARKET

The impact of COVID-19 triggered a series of unprecedent situations that impacted all spheres of life. The epidemic swept the globe like wildfire, putting everything on hold, and altering perspectives. The disease not only became a worldwide pandemic but also had an impact on each country's economic growth on order. To mitigate the spread of this fatal virus, the majority of the world's nations were compelled to implement a lockdown that had an adverse effect on every industry, interrupting the chain of supply and demand. and altering even world economies. Post the lockdown, economies reduced income while keeping expenses and operating costs constant. Businesses' operations and workings were halted, layoffs and employee remuneration were impacted, with fixed costs added to the pressure, and growth remaining minimal.

The financial markets were also not an exception. The cave-in began in mid-February 2020, but it intensified in March. On March 16, the world's stock markets experienced a dramatic decline of 12–13%, known as "Black Monday." The financial markets were also not an exception. The cave-in began in mid-February 2020, but it intensified in March. On March 16, the world's stock markets experienced a dramatic decline of 12–13%, known as "Black Monday."

The Dow closed at 23,553.22 on March 11, down 20.3% from its peak on February 12. Consequently, the markets went into a bear phase after the end of the bullish phase which almost lasted for 11 years. The S&P 500 Index fell by 34% to a low of 2,237.40 by 23 March 2020. Everyone were struck with losses as the investors' risk continued to shoot upwards.

The effect that COVID-19 had on the Indian stock market could be easily witnessed through the BSE and NSE- two major Indian stock exchanges. On 23 March 2020, the Sensex fell by 13.2%, recorded as the biggest decrease in a single day since the Harshad Mehta fraud (1991). NIFTY also experienced a similar 29% decline at the same time. Ironically, the highest peaks at 12362 and 42273 were reached respectively by both NSE and BSE, just two months earlier in January, with positive outcomes.

Due to COVID-19, the Indian Stock Market experienced a "Black Swan Event," which is a rare, improbable, beyond-expected event that unquestionably has devastating implications. A demand-side shock resulted in investment uncertainty caused by the lockdown policy and its implications. When fewer investors wanted to buy the stocks, everyone wanted to sell them, which increased supply and finally caused prices to decline. Studies show that other pandemics had an impact on the supply side, whereas the COVID-19 pandemic had no such restrictions and even to some extent disrupted supply systems.

The stocks of these companies fell by more than 40%, and industries like aviation, hospitality, leisure, and entertainment were among those that were most adversely impacted. However, history suggests that such stock market volatility and crashes are just momentary because no crisis lasts for an extended period of time. In reality, evaluated from a different angle, this decline presents investors with a chance to enter the stock market and generate higher returns in the long run. Investors are advised to rebalance their portfolios during market downturns and steer clear of using too much leverage. Even after April 2020, the stock market recovered, and it has been performing positively since then.

The 2020 crash was nothing less than a knee-jerk reaction, but recently, things have started to return normal. to Manufacturing and industrial activity have picked up speed, along with the IT sector. Even the economic and budgetary indices show signs of strength, providing encouragement and proving that the worst is over.



Whether or not, there is another stock market crash will be interesting to watch. Therefore, there is no denying that even if a crash occurs again in 2022 as a result of the additional waves of COVID-19, it will only be brief and eventually be resolved.

SUSTAINABILITY OF CRYPTOCURRENCIES – CASE STUDY OF FINLAND AND ETHEREUM CONTRACTS

Is the usage of cryptocurrencies sustainable in the present day and age, given its drawbacks? Could this be the answer to problems regarding that of curbing corruption, poverty and red-tapes? Well, here is an article which shall talk about the sustainability of cryptocurrencies, real-life a application of Ethereum contracts in Finland and as to how India could apply the same. But before we get into the topic let us first understand meaning words the of the sustainability and cryptocurrency. Sustainability can be defined as fulfilling the needs of the present without compromising the needs of the future by ensuring a balance between economic growth, the environment and well-being.

Cryptocurrency can be defined as a digital currency secured bv cryptography which is impossible to counterfeit, print or double spend. The reason why this form of currency is in the limelight is that behind the technology cryptocurrency, that is blockchain, is to ensure that the existing monetary systems are decentralized and it allows two parties to transact in terms of value or money without the interference of an intermediary financial such as a bank or institution. By clubbing both the definitions together, the question at hand is: Is the usage of crypto, backed by blockchain, capable to satisfy the present needs of the generation without hampering the needs of the future?

Setting an exemplary example, Finland uses a remarkable application of blockchain amidst Ethereum known as 'Smart Contract'. It ensures that transactions are traceable, transparent and irreversible. To give a quick perspective, in 2016 Finland was struggling to deal with a refugee settlement. During the crisis, the Finnish government partnered with a local fintech start-up called Moni that initiated the prepaid MasterCard. It linked blockchain was to in collaboration with the Immigration Services of Finland. This had numerous features to its credit and aided in getting government subsidies.

For instance, if Mr. A, was an asylum seeker who was eligible for a 10% and 6% subsidies in essential goods, in year respectively, then his and 2 1 MasterCard would get updated in such a way that he would automatically receive 6% subsidy for his purchase of essential goods using the MasterCard. The Mastercard would he technologically advanced such that it would automatically revoke the subsidy if Mr. A's income exceeds \$10,000 for consecutive 3 months. This is because Mr. A is rich and no longer requires subsidies. Now how can India use such smart contracts to solve problems which are present in our society?

The prime problem is government subsidy allocations. As of 2016, there was a report that said that almost 1,00,000 crore rupees were being unevenly distributed for the betterment of the less privileged population. The rich due to multiple reasons such as corruption, fake documents, and lack of technological tools, allocate subsidies based on forged data.

Secondly, the issue of fake documents is persistent throughout. They are easily accessible to individuals to acquire forged caste certificates or income certificates. Using these certificates people go on to claim thousands or even lacs of rupees in subsidies for college fees, essential commodities, and food alone. We must strongly advocate the need for a system that can repeal and distribute these subsidies based on the progress that people make. The third problem is that India is facing a data management crisis. This was backed by the fact that almost 65 Lakh tons of food grains were being wasted due to lack of storage while almost 200 million Indians lacked basic nourishment during the first twoquarters of the COVID pandemic, highlighting the corruption and lack of data processing systems.

TOKENIZATION : SAVING THE CUSTOMER FROM ONLINE FRAUD

"Technology will offer fraudsters an advantage, but it will also give enterprises new tools to deal with them."

The Reserve Bank of India issued a circular to all payment aggregators and payment gateways on March 17, 2020, instructing them to set up their infrastructure to tokenize their services. This essentially meant that no company or person was permitted to store the information about their clients on their server. Only networks and card issuers were permitted to hold this information.

Looking at a brief history of tokenization, the British Empire in the 17th to 19th centuries is where the earliest token applications first appeared. During this time, when fiat currency was unavailable tokens were used instead of cash to facilitate the purchase of certain goods. Let's attempt to put the tokenization's current significance into perspective. Today, the process of "tokenizing" involves swapping sensitive data for non-sensitive data known as "tokens."

Tokens, once created, cannot be reversed decrypted, unlike or encrypted data. This differentiation is especially crucial. Tokens cannot be converted back to their original number since there is no mathematical connection between them and their original number; unless this is stored separately. In this process, instead of saving ones card details on platforms such as Amazon, Flipkart or Zomato either one would or rather the system will use the unique token to verify transactions.

Globally, and in India, the Covid epidemic turbocharged the already expanding e-commerce. People who were forced to stay at home, either on their own will or as a result of government order, lookup the chance to shop online. According to reports, India's e-commerce may increase from \$46.2 billion (pre-pandemic level) to \$111 billion by 2024, thereby increasing chances of online fraud. The Business Standard recently stated that 42% of Indians had fallen victim to financial fraud in the previous three years. By adding an extra layer of security to the sensitive data that users store on their credit cards, tokenization helps to prevent/reduce online fraud and data breaches.

Will tokenization have a future? Tokenization is here to stay despite its current issues such as little practicebased proof, a lack of regulation and infrastructure, as has been the case with any technology that demonstrates a "value."

The latter is the situation in India, where despite everyone's best efforts, the date for the full deployment of tokenized payments has been pushed back several times, with the current estimate being in September 2022. Tokenization will develop and improve as it connects with cuttingedge technology like cloud computing and blockchain and offers even greater scope across many industries. Tokenization is a permanent trend and here to stav.

> The beginning is the most important part of any journey, and that's how it all began back in March 2021 when we all witnessed the start of a massive social signing outreach with the MOU ceremony between Christ University & Chakkittapara Service Co-operative bank, which led to the course of ideation and exploration about the Chakkittapara village after research and analysis revealed the true potential of the town and the will & spirit needed to start the mega project with the aim of Chakkittapara, making a gram panchayat in Kozhikode district of Kerala, as one of the first fully 100% insured gram panchayat in India.

> A training session was arranged between the bank officials and the students of Christ university as an initiative to bridge the gap between Christ and Chakkittapara. Further along this path was the Sammilan Event- "Together we Explore", a two day training workshop on insurance



that was spearheaded by the students for the staff of the Cooperative Bank of Chakkittapara.
