In this context, the School of Law, CHRIST (Deemed to be University), is hosting the International Symposium on "Changing Global Order in South Asia: Balancing Sovereignty, Security and Human Rights" from 15<sup>th</sup> to 16<sup>th</sup> January 2026. # SUB-THEMES

## 1.1.1 Armed Conflicts and National Security

### Sub-Themes:

- Application of International humanitarian law in Contemporary Conflicts with its challenges in its application to hybrid warfare and non-state actors
- Balancing Counter-Terrorism and Civil Liberties with a comparative study of surveillance laws vis-à-vis human rights safeguards
- Corporate and State Responsibility in Arms Transfers: Accountability under the Arms Trade Treaty<sup>im</sup>
- Civilian Protection in Cross-Border Operations in reference to Refugee rights and internally displaced persons under international law.
- Accountability Mechanisms in war crimes, and fact-finding commissions in prosecuting violations.
- Legal regulation of drones, private military contractors, and cyber warfare in armed conflicts.

## 2. Human Rights, Immigration, Refugees, and Statelessness

### Sub-Themes:

- Refugee Protection under International Law with the Gaps in the 1951 Refugee Convention
- Statelessness in South Asia regarding Citizenship, gender-based exclusion, and birth registration challenges.
- Regional Migration Governance over SAARC and its limitations compared to global compacts on migration/refugees.
- Displacement and Humanitarian Response, with emphasis on the role of NGOs and NHRIs in securing access to education and healthcare



# SUB-THEMES

## 3. Climate Obligations

### Sub-Themes:

- State Responsibility under International Environmental Law in compliance with the International Agreements
- Comparative analysis of national approaches to renewable energy transition.
- Climate Litigation with the usage of courts as instruments of accountability for state inaction.
- Regional Cooperation with emphasis over Case studies on transboundary resource management (river basins, ecosystems).

## 4. Cyber Warfare

### Sub-Themes:

- International Law and Cyber Operations with the applicability of Tallinn Manual principles to state-sponsored cyberattacks.
- Comparative analysis of Domestic Cybersecurity Frameworks with EU/US cybersecurity laws.
- Countermeasures to cyber warfare with emphasis on the accountability and regulation
- Information Warfare in relation to Manipulation, disinformation, and election security in cyberspace.



# SUB-THEMES

## 5. Global Trade, Opportunities, and Economy

### Sub-Themes:

- Trade as Peacebuilding with relation to the case studies of economic interdependence reducing conflicts.
- Geopolitical Alliances and Trade Realignment with reference to friendshoring, trade blocs, and shifting supply chains.
- WTO Dispute Settlement Crisis with Reform prospects and implications for global trade order.
- Trade Amid Fragmentation in relation to Tariff wars, protectionism, and resilience strategies for global supply chains.

NOTE – The authors are allowed to explore sub-themes as per the main theme of the Symposium



# GENERAL GUIDELINES

## Who Can Participate?

Participants from across the globe are invited, particularly scholars, policy makers, legal practitioners, diplomats, human rights activists, academics, research scholars, students, representatives of NGOs, think tanks. The organizing committee seeks diverse participation from different countries and regions to ensure a multiplicity of viewpoints in discussions.

## Symposium Structure: Hybrid (Online & Offline)

The symposium will be organized in a hybrid format, allowing delegates to participate either in person at the designated venue or virtually through an online platform. All keynote speeches, plenaries, and thematic sessions will be accessible to both onsite and remote participants, promoting broad international engagement and flexibility.

## Accommodation Guidance

Participants are required to manage their own accommodation arrangements. The organizing committee may provide recommendations regarding hotels and guesthouses in the vicinity of the symposium venue, but all bookings, payments, and related logistics are the sole responsibility of the participants. Early accommodation planning is recommended due to possible high demand.

## Selection Criteria for Paper Presenters

Abstracts and paper proposals will be evaluated competitively. The criteria for selection include:

- Relevance to the symposium's overarching theme of balancing sovereignty, security, and human rights amid the changing global order in South Asia
- Quality, originality, and analytical clarity of the submission



# GENERAL GUIDELINES

- Geographical and institutional diversity among presenters
- Potential for the paper to stimulate interdisciplinary and cross-sector dialogue
- Final selection will be made by an expert review panel, and only a limited number of abstracts will be accepted for presentation and potential publication.

## Abstract Submission Guidelines

The abstract should be approximately 300–350 words and clearly state:

- Title of the paper
- Symposium theme
- Sub-theme
- Brief description of the Authors, submitted on a separate page, including:
  - Full name
  - Designation
  - Educational qualifications
  - Professional status/affiliation
  - Contact address and mobile number



# SUBMISSION GUIDELINES

Kindly adhere to the following submission guidelines while preparing your manuscript:

1. **Abstract and Keywords:** Each paper must include a short abstract (300-350 words) and relevant keywords
2. **Word Limit:** 5,000 to 10,000 words
3. **Plagiarism & AI Check:** The overall similarity index (including AI-generated content) must be less than 10%, with no single source exceeding 2%. Papers exceeding this limit will not be considered.
4. **Referencing:** Referencing: Footnotes must follow APA (7th Edition) format consistently. No endnotes required.
5. **Font:** Times New Roman, Font Size: 12, Spacing: Double
6. **Spelling:** UK spelling (except in quoted text, which should retain the original)  
UK spelling and hyphenation: As per the Concise Oxford Dictionary.
7. **Page Numbers:** Bottom centre, numbered sequentially (1, 2, 3, etc.)
8. **Software:** Manuscript to be prepared in Microsoft Word 2010 or above
9. **Headings Style:**
