POLICY FRAME WORK

- Research committee members shall be nominated by Head, Civil engineering Department.
- All the faculty members shall take up internal or external funded projects in collaboration with industries, research organisations in core / interdisciplinary areas.
- Researchers involved in internally/externally funded projects shall comply to the rules and regulations of CHRIST (Deemed to be University) and funding agency.
- Periodic submission of progress report and the utilisation certificate shall be submitted promptly as per the requirements of the concerned authority.

- All faculty members to publish research papers in indexed journals at least one in two years.

GUIDELINES

To achieve the objectives of research policy, the research committee shall guide and support the researchers in the following aspects.

- On privacy rights of researchers.
- To provide training in emerging areas of civil engineering and ethical practices in research
- To review and recommend the research proposals on the basis of merit.
- Involvement/participation of under graduate students in research projects taken by faculty.
- Faculty to attend national and international conferences as recommended by the committee.
- Research projects and progress in research taken up by faculty to be presented periodically to the faculty and the students for dissemination.
- Reduction in teaching work load for the faculty involved in extensive research.
- Recommendation for reimbursement of expenses incurred in publication in indexed journals as per university policy
- Recommending leave for attending conferences and workshops

As per the purpose, objectives and guidelines of research policy, Civil engineering department shall function strategically in achieving the objectives of the policy and ultimately to serve the society with research outcomes.
