- ❖ Author(s) name, address, e-mail ID and phone number(s) are to be furnished in the cover page along with the title of the paper
- ❖ Practitioners or institutional representatives who wish to present model(s) of Service-Learning in their universities or colleges may contact the coordinators. An exclusive session shall be organized for the presentation of the same
