Brief report on various Guest Lectures/Speaker Sessions

Speaker Session on "Fostering Global Vision: Exploring Entrepreneurship in the 21st

Century."

Speaker: Dr. Blaine McCormick, Associate Professor at Baylor University

On January 4, 2024, a guest lecture titled "Transformative Pedagogy: Unveiling the Impact of Learning Management Systems on Management Course Outcomes" was held from 11:00 AM to 1:00 PM in Room No. 801, Ground Floor, Audi Block, at Bangalore Central Campus. The session was delivered by Dr. Blaine McCormick, an Associate Professor at Baylor University, and was attended by 40 faculty coordinators from the School of Business and Management.

A key highlight was Dr. McCormick's analysis of the Coca-Cola case study, which he used to illustrate his global workshop experiences. He expertly applied the 4Ps of Marketing—Product, Price, Place, and Promotion—to various scenarios, offering practical insights into real-world applications. Additionally, he presented a research paper listing the top 15 businessmen in the United States over several decades, explaining how these leaders' contributions shaped the country's infrastructure.

Dr. McCormick's lecture centered on the evolution of teaching methodologies in management education, with a particular emphasis on the pivotal role of Learning Management Systems (LMS) in enhancing course outcomes. He began the session by posing a thought-provoking question regarding the fundamental management courses that underpin effective teaching strategies. Drawing from his extensive experience, Dr. McCormick shared research conducted by both himself and his students on intriguing topics such as theft and drug usage, which captivated the audience. This enlightening session has also laid the groundwork for COIL (Collaborative Online International Learning) projects in areas like marketing, supply chain management, and finance. These projects involve students from both universities collaborating on a joint project, with guidance from professors at each institution. The duration of each project is expected to be around 15 hours. The session concluded with a discussion on the intersection of Christian ethics and business concepts, where Dr. McCormick emphasized the importance of wisdom and resource management, reflecting the teachings of Bible scholars. This lecture provided participants with a rich understanding of transformative pedagogy in management education.

Attended by 79 students from 4th BBA C and 3rd Year Specialization, the session highlighted the contributions of Indian entrepreneurs to U.S. infrastructure and examined Benjamin Franklin's business achievements. The session was a blend of historical and modern perspectives on business, with discussions on Benjamin Franklin's biography, Indian contributions to U.S. infrastructure, and marketing analytics. Students gained a deeper appreciation for the role of historical figures like Benjamin Franklin in shaping modern business practices, particularly in the context of entrepreneurship. Also, the discussion on Indian entrepreneurs' contributions to U.S. infrastructure expanded students' awareness of the global impact of entrepreneurship.

Dr. McCormick's insights, including his research on top U.S. businessmen, provided valuable lessons on modern entrepreneurship. The event was well-received, broadening the students' entrepreneurial perspectives.

The diverse viewpoints presented by the participants enriched the discussion, offering a broad spectrum of perspectives on the ethical and moral implications of capitalism in today's society. The lecture was highly interactive and engaging, offering valuable insights into contemporary business issues. The combination of case studies, discussions, and a thought-provoking debate made the event a highly enriching experience.

He advocated for a practical, hands-on approach to learning, where students are encouraged to develop their business ideas, understand market dynamics, and navigate the challenges of starting and growing a business.

Dr. McCormick's validation ensures that these subjects are aligned with global standards and are designed to equip students with the skills and knowledge required to succeed in the dynamic business environment.

The Semester Exchange and Summer School programs offered by the School of Business Management are integral components of the BBA curriculum, designed to provide students with international exposure and a global perspective on business education. These programs are facilitated by the International Cell through partnerships with prestigious universities around the world.

Description on Semester exchange and summer school

Semester Exchange Program:

The Semester Exchange program allows students to spend an entire academic semester at one of the partner universities abroad. This immersive experience enables students to engage with different educational systems, cultures, and business practices, thereby broadening their understanding of global business environments. The program is typically offered during the fourth semester of the BBA curriculum, aligning with the department's vision of nurturing globally-minded leaders. Through this program, students can transfer credits earned at the host university back to their home institution, ensuring that their international experience contributes directly to their degree requirements. The exchange experience also fosters personal growth, adaptability, and a deep appreciation of diversity, all of which are essential qualities for future business leaders. Approximately 9 students have successfully completed their semester exchange programs with various universities.


