ABSTRACT

The wives of individuals with alcohol dependence had suffered from intense trauma and stress in their family environment, which caused them significant psychological and social problems. Thus, there was a need to study the psychological and social well-being of wives of individuals with alcohol dependence through support group participation. The study aimed to examine the impact of support group participation on the psychological and social well-being of the wives of individuals with alcohol dependence. The study followed an explanatory sequential approach and adopted a descriptive research design for the quantitative phase and a descriptive phenomenological research design for the qualitative phase. The study used a purposive sampling technique to identify the participants. Descriptive, inferential, and content analyses were the methods of analysis.

The study results showed how support group participation impacted the psychological and social well-being of the participants. It also demonstrated the relationship between support group participation, demographic characteristics, psychological well-being, and social well-being. The study results narrated the problems faced by the wives of individuals with alcohol dependence: financial burdens, domestic violence, marital conflicts, and psycho-social challenges. However, the participants highlighted that after joining the Support Group, their lives changed significantly, and they were able to experience mental peace, calmness, and social acceptance. The transformation in their lives enabled the participants to resume their education, socialize with the community as role models and leaders, and rebuild their lives as earning individuals.
