## **ABSTRACT**

This thesis examines how biblical women are reimagined in the afterlife of the Bible through contemporary biblical fiction. The primary texts under consideration include India Edghill's *Queenmaker* (2002), *Wisdom's Daughter* (2004), and *Game of Queens* (2016), along with Tessa Afshar's *Harvest of Rubies* (2012), *In the Field of Grace* (2014), and *Pearl in the Sand* (2020). These narratives foreground the voices, agency, and resilience of select biblical women, functioning as counter-narratives to longstanding androcentric interpretations.

This study interrogates patriarchal representations embedded within traditional biblical hermeneutics and adopts a feminist interpretive framework informed by the works of Elisabeth Schüssler Fiorenza, Luise Schottroff, and Phyllis Trible. The central argument posits that these retellings construct a 'herstory' of biblical women, rooted in feminist consciousness, which recovers and amplifies their lived experiences and subjectivities. Furthermore, the study argues that such contemporary reinterpretations not only offer renewed perspectives on women of the biblical past but also yield critical insights applicable to present and future gender discourses. The selected narratives by Edghill and Afshar emphasize the necessity of reimagining historical and religious narratives to center female voices, thereby contributing to broader conversations surrounding gender, power, and representation in literary contexts.
