Greetings from the Office of Examinations!

Students who were absent or not eligible to appear for the Mid-Semester Examination (MSE) in August 2025 due to low attendance in Theory courses, Multi-Disciplinary Courses (MDC), and department level submission courses (excluding HED) are required to apply online through the student KP portal for the Repeat Mid-Semester Examination, August 2025.

Students are advised to apply for all courses (*Theory courses*, *Multi-Disciplinary Courses* (*MDC*) and department level submission courses) reflected as ineligible in your KP portal and hall ticket.

The Controller of Examinations will take the final decision regarding marks exemption, fee exemption, or the asterisk on the marks sheet, based on the documents submitted with the repeat application form and the attendance records available in KP.

Students must attach relevant supporting documents with application, such as:

- Medical certificates and a letter indicating prior intimation and approval from the Head of the Department, if the shortage of attendance was due to medical reasons.
- Participation/attendance certificates for events or programmes approved by the department / School or University.
- A prior permission letter submitted to the Office of Examinations, duly recommended by the Dean/ respective Head of the Department (HoD), permitting the student to appear for the Repeat MSE due to participation in government/university examinations, SWAYAM course examinations, competitive exams, certification programmes, or internships.
