## **ABSTRACT**

The thesis explores the indigenous ecological traditions among the Kukis of Manipur, India. Tribals preserve, use and form their worldviews based on traditional ecological knowledge (TEK). TEK is a repository of indigenous beliefs and practices about human-nature relationships passed down through generations within specific cultures. Indigenous people usually relate to various ecosystems through TEK and their spirituality. In Manipur, the Kukis are a minority in population, but they live in vast forest areas that are ecologically significant. The indigenous Kukis were affected by the advent of industrialisation in the eighteenth century and the anthropocentric mindset in the nineteenth century, which contributed to the loss of natural resources, biodiversity and led to environmental degradation. In the present socio-political scenario, on the pretext of development, poor people are expatriated from their homes and the forest they live in, and they become ecological refugees in their land. After the Kuki people embraced Christianity in the latter part of the nineteenth century, there was a sense of distancing themselves from nature. The Kukis derive ecological knowledge from their environment and find reflection in their language, village governance, philosophy of life, oral tradition, customary health care, herbal medicine, and social learning techniques. In-depth interviews, participatory rural appraisal (PRA) and participant observations were used to collect data. The data was analysed through NVivo 12. The Kuki tribes believe that their surroundings are sacred and humans are impermanent earth owners. Indigenous ecological traditions could contribute to broader discussions on environmental conservation, sustainable development, and mitigating climate change.
