ABSTRACT

The thesis 'Environmental Communication Strategies in Civil Society Formations: A phenomenological Study of Marupakkam and PMANE (Peoples Movement Against Nuclear Energy)' examines the role of strategic communication in environmental advocacy, focusing on the phenomenological study of Marupakkam's Green Film Festival, 2022 and the People's Movement Against Nuclear Energy (PMANE). The study highlights how these civil society formations utilise diverse communication strategies to inform, engage, and mobilise communities through detailed phenomenological research, including in-depth interviews, content analysis of digital media, and participant observations. Marupakkam utilises narrative films to raise environmental awareness among youth, while PMANE employs conventional media and digital campaigns to combat nuclear power plants. The findings demonstrate that effective communication strategies increase public awareness and foster significant community engagement and mobilisation, contributing to broader environmental advocacy. This research underscores the need for adaptive communication approaches that resonate with local contexts and challenges, offering valuable insights for enhancing future environmental movements and policies. Building on these insights, the study proposes an 'Integrated Communication Model for Social Movements' and a 'Dynamic Communication Framework for Environmental Advocacy'.
