ABSTRACT

This thesis explores the transformation of the internet as a public sphere in India and its impact on democratic identity, focusing on the roles of state governance and corporate networks. By using data-driven by multi-sited digital ethnography, it examines the power struggle between state and corporate apparatuses, revealing how these dynamics create an unreliable public sphere that weaponizes democracy for self-exploitation. The thesis highlights how digital technologies, particularly AI, manipulate the formation of publics, distort knowledge production, and alter identities and perceptions of truth. The conflict between government and corporations distorts life-world interactions, disrupting rational critical discourse and causing polarisation, confusion, and misinformation.

In the Indian context, diverse socio-political identities and the cultural and ideological distinctiveness of the populace make the digital public sphere especially susceptible to manipulation. The state's regulatory framework, ostensibly aimed at protecting the public, often collaborates with corporate interests, resulting in data colonialism, information manipulation, and commodified public identities. These distortions challenge democratic ideals, fragment public discourse, and erode the democratic potential of the internet by creating filter bubbles and echo chambers.

The thesis argues that this digital environment fosters a neo-colonial control over knowledge, impacting privacy, free speech, and public opinion. However, civil society plays a critical role in preserving India's democratic identity by offering alternative narratives, promoting critical discourse, and advocating for digital rights. Ultimately, this research underscores the precarious nature of the Indian digital public sphere, where state and corporate interests dominate, yet the potential for democratic engagement persists through civil society's interventions.
