ABSTRACT

This research highlights the status of Kashmiri pashmina shawls as geo-cultural artefacts that retain the region's heritage, artistry, and identity. It underscores the ingenuity and skill of Kashmiri artisans who, through weaving, dyeing, and embroidery, transform raw materials into the textiles of cultural and historical significance. By examining the relationship between textiles, memory, and place, the study reveals how pashmina shawls conserve and transmit cultural narratives, serving as repositories of both social and personal memory. The research explores the historical and external influences that have shaped Kashmiri crafts. Positioned at the crossroads of Central Asia and the Indian subcontinent, Kashmir has long been exposed to diverse cultural, artistic, and commercial interactions. While the Mughals and trade routes introduced new techniques, motifs. and designs, Kashmiri artisans adapted and innovated, creating a distinctive aesthetic. The study asserts the ingenuity of Kashmiri artisans in developing the buta or paisley motif, as a local symbol, holding their creative resilience amidst external influences. Focusing on Kashmir's rich crafts heritage, the research situates the pashmina shawl within the discourse of memory studies and material culture. It explores how these artefacts encapsulate collective heritage while reflecting personal memory, illuminating their role in shaping identity and fostering intergenerational memory. Through the lens of Paul Connerton's theory on memory transmission via bodily practices and ceremonies, the study sheds light on the shawls' enduring significance as cultural carriers across generations.

The research reads the pashmina shawl as an ethnographic text, focusing on the *Pashmina Map Shawl* housed at the Victoria and Albert Museum and the *Samavor Shawl* designed by Javaid Rathar. These cultural artefacts provide insights into Kashmiri daily life and symbolism, with emphasis on the motifs woven into these shawls. Drawing on Roland Barthes' semiotic framework, the study analyzes these motifs as signifiers, unpacking their layers of meaning and exploring their role in constructing narratives of identity and memory. By treating pashmina as a social and communicative object, the research highlights its ability to convey cultural and historical narratives, serving as both a material and symbolic artefact. The motifs interpreted as visual texts function not only as aesthetic elements but also as carriers of socio-cultural significance, bridging narratives with collective memory. This approach holds the pashmina shawl's dual role in Kashmiri culture: as a repository of memory and as a medium for the expression of identity and shared heritage. By engaging with interdisciplinary perspectives on memory studies, material culture, and artistic heritage, this study illuminates the pashmina shawl's role as a narrative artefact of transmission. It argues that these textiles bridge past and present, anchoring Kashmiri identity in a rapidly changing world while celebrating the resilience and creativity of its artisans. This research offers insights into memory, materiality, and cultural sustainability, advancing our understanding of how material culture shapes and preserves collective heritage.
