## **National Workshop on Contract Drafting Skills** **14 Feb 2024**

**Venue:** 911, Central Block, CHRIST (Deemed to be University), Central Campus

**No. of Participants:** 120

The School of Law, CHRIST (Deemed to be University), Bengaluru, organised the 1st National Contract Drafting Workshop and Competition 2024 in collaboration with Nishith Desai Associates. The national-level workshop featured industry experts, including Ms Harshita Srivastava, Co-Head of the M&A Practice at Nishith Desai Associates. The event focused on developing practical contract drafting skills through discussions on transaction documents, investment stages, and key legal agreements. Participants, comprising students from three-year and five-year LL.B. programs across India, engaged in both learning sessions and a hands-on drafting competition. The activity provided an excellent blend of theoretical insight and practical experience, strengthening students' understanding of commercial contract drafting and enhancing their professional competencies.



## **1st National Symposium on Corpus Juris Nexus 29 Sep 2023**

The 1st National Symposium on Corpus Juris Nexus created a platform for students to explore intersections of law, policy, and corporate governance. The interactive sessions and panel discussions encouraged students to analyse current corporate legal challenges. Speakers emphasised the importance of responsible governance and equitable business practices. Participants engaged in dynamic Q&A sessions that sharpened their critical thinking and analytical skills. The symposium promoted an inclusive learning environment that connected theoretical frameworks with practical applications. Supporting SDG 10, it reduced academic and regional barriers by giving students from various institutions access to national-level discourse on corporate jurisprudence.





## **14th National Moot Court Competition (with Cyril Amarchand Mangaldas) 2-4 Feb 2024**

Participants were mentored by experts from Cyril Amarchand Mangaldas, bridging academic learning with professional exposure. The initiative fostered fair participation and merit-based recognition, supporting SDG 10 by ensuring equitable access to legal education experiences. The competition concluded with awards for best memorial, oralist, and team performance, inspiring students toward responsible and socially conscious legal practice.

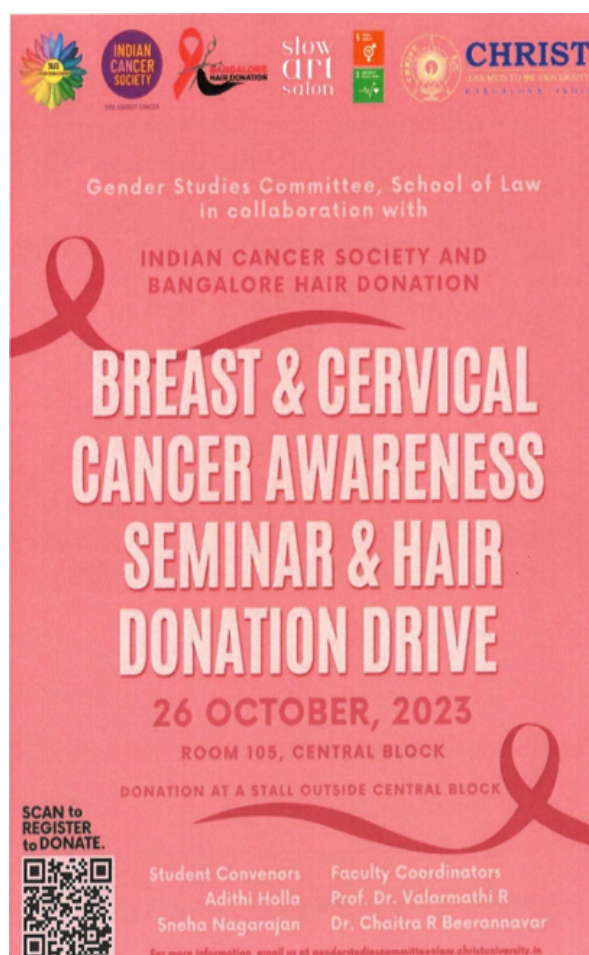
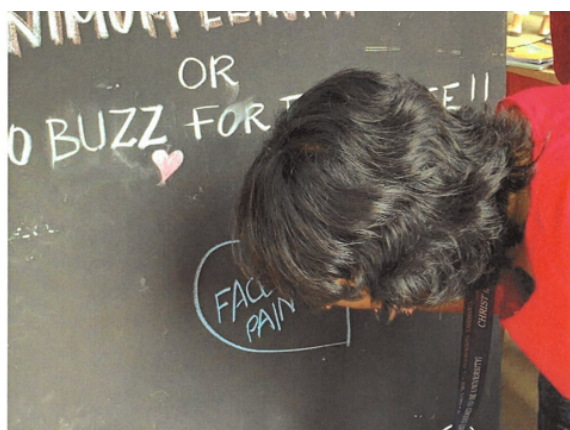


## **Breast & Cervical Cancer Awareness Seminar & Hair Donation Drive 26 Oct 2023**

Emphasising a child-centric approach, the course prioritised children's well-being, rights, and protection across all aspects of law enforcement. Participants developed a nuanced understanding of juvenile justice procedures and child protection mechanisms, aligning the program with SDG 10 (Reduced Inequalities) and SDG 16 (Peace, Justice, and Strong Institutions).

The Christ University Parliamentary Debate was conducted from 5th to 7th April 2024, providing a platform for students from across India to engage in intellectual discourse using the Asian Parliamentary Debate format. Participants and adjudicators competed across several rounds, with motions designed to test argumentation, analytical reasoning, and teamwork. The event allowed students to showcase their debating abilities while encouraging dialogue on diverse social, political, and ethical issues. External adjudicators scored performances based on a structured rubric devised by the organising committee. The debate nurtured inclusivity by welcoming teams from different universities, reflecting the spirit of equal opportunity in academic discourse. 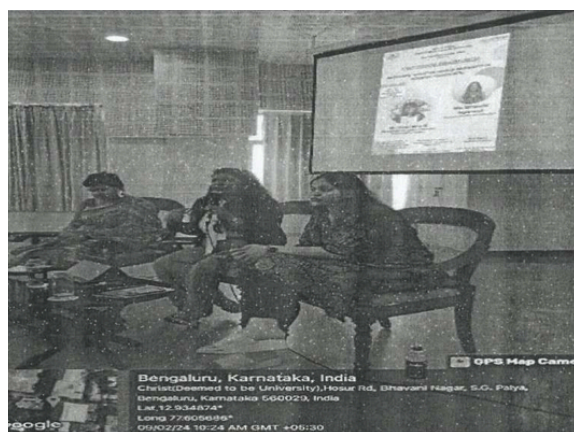
## **Glimpses of Liberty, Equality, and Justice for All - A Human Rights Perspective**



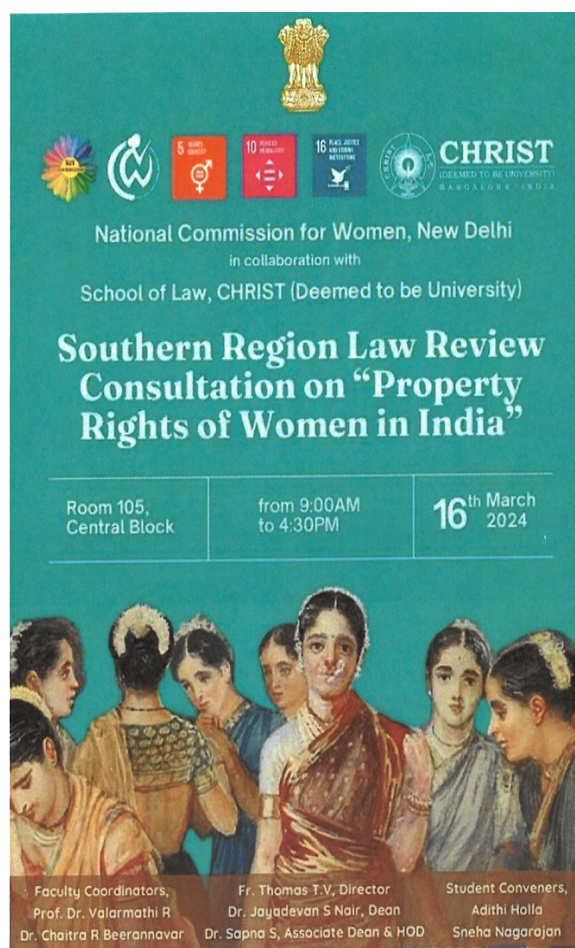
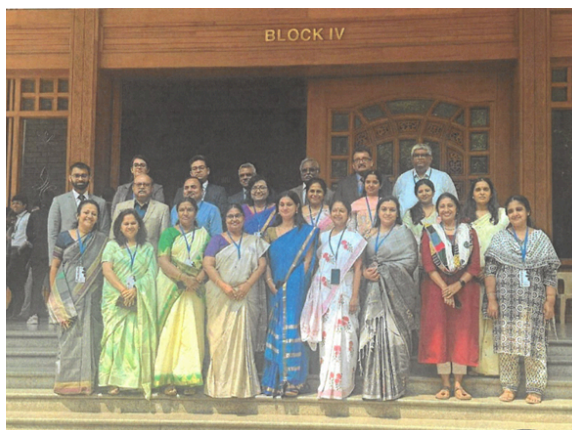
## **Southern Regional Law Review Consultation on Property Rights of Women in India**

**16 March 2024**

**Venue:** Block 4, CHRIST (Deemed to be University), Bangalore

**No. of Participants:** 31

The School of Law, CHRIST (Deemed to be University), organised the Southern Regional Law Review Consultation on Property Rights of Women in India to examine inheritance laws, marital property rights, and gender equality reforms. The consultation aimed to address historical disparities and contemporary challenges affecting women's access to property ownership. Conducted in collaboration with the National Commission for Women (NCW), New Delhi, the event comprised three sessions featuring experts, judges, advocates, and academicians who analysed Hindu, Christian, Muslim, and Parsi property laws. Participants deliberated on legal precedents, societal norms, and recent developments to identify equitable reforms. The discussions produced multiple recommendations to make existing laws more just and inclusive for women. The NCW will compile these outcomes into a formal report for legislative consideration. The initiative aligned with SDG 5 (Gender Equality) and SDG 10 (Reduced Inequalities) by promoting gender-sensitive legal reform.





## **Menstrual Leave Policy in the Workplace**

The Gender Studies Committee of the School of Law, CHRIST (Deemed to be University), organised a skit to introduce the Labour Department's discussion on menstrual leave policy and its relevance for ensuring equitable workplace conditions. The performance addressed stereotypes surrounding menstruation, emphasising awareness, inclusivity, and the need to create supportive professional environments. Through a mediation-style enactment, the skit explored diverse perspectives on menstruation as a natural process and the importance of sensitivity among employers and peers. It highlighted organisational, legal, and social implications of menstrual leave, while underlining the necessity for comprehensive policies to address health, comfort, and productivity. The event encouraged dialogue on gender equity in the workplace, aligning with SDG 5 (Gender Equality) and SDG 10 (Reduced Inequalities). The follow-up plan included facilitating discussions with the State Commission on Menstrual Leave Policy to promote legal and institutional awareness at a national level.

### **No. of Participants:**

The School of Law, CHRIST (Deemed to be University), organised the 14th National Conference on Enhancing Judicial Administration in India: Application of Procedural Laws and Ensuring Access to Justice on 22–23 January 2024. The flagship event attracted over 100 submissions from scholars across the country, of which select papers were presented in the conference sessions. The forum provided a platform for academic discussion on procedural reforms, digital access, and transparency in the justice system. Eminent guests, including Hon'ble Justice P.S. Dinesh Kumar, High Court Judge, delivered insightful addresses. Deliberations emphasised efficient case management, strengthening ADR mechanisms, accountability, and judicial capacity building. 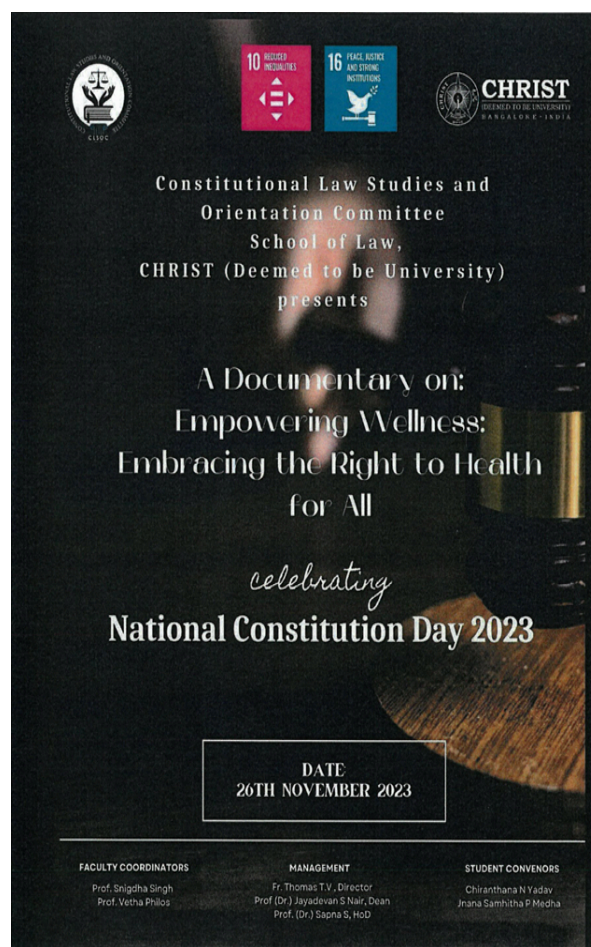
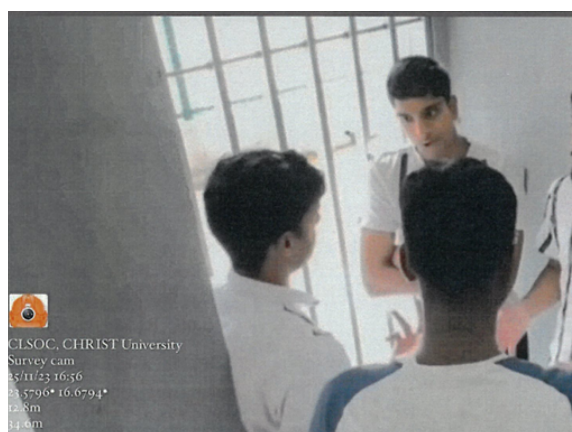


## **Empowering Wellness: Embracing the Right to Health for all| 26 November 2023**

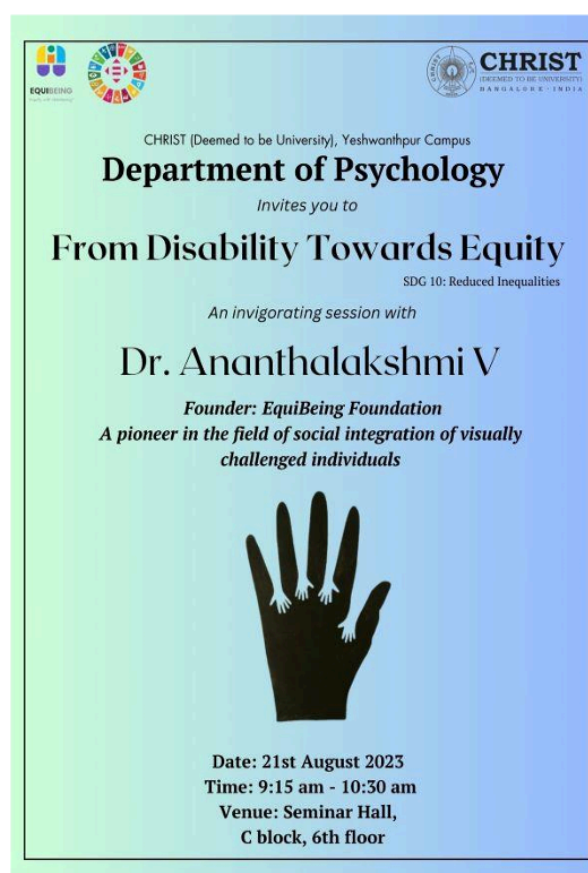


## **From Disability Towards Equity** **21 August, 2023**

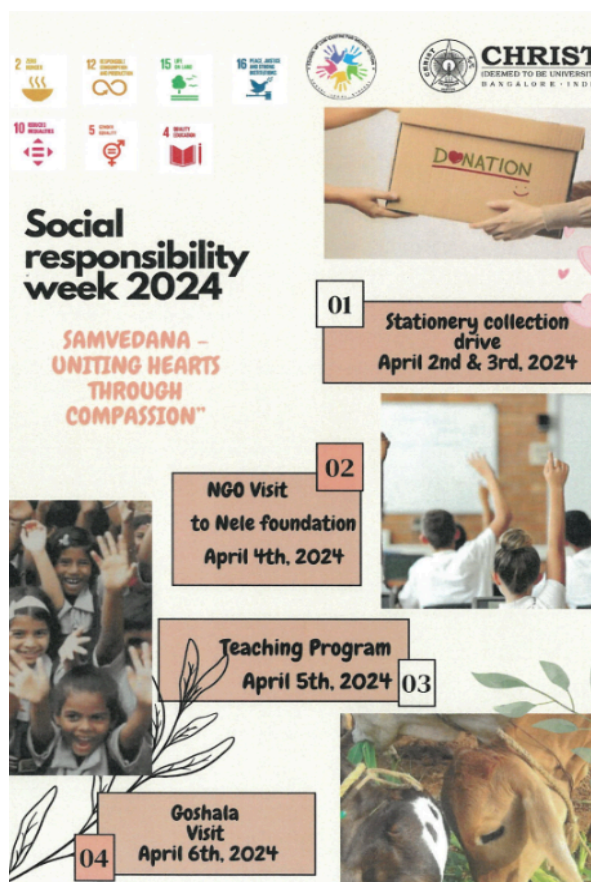
## **Importance of communication skills and developing empathy among each other, break the stereotypes, and express better**

The Teaching Program was held in Madiwala, one of the project areas of the Centre for Social Action (CSA). The session involved students from classes 2 to 9, focusing on developing communication skills and breaking stereotypes among the participants. The activities were designed to help students express themselves confidently through fun, engaging exercises. The session began with an introductory activity where students paired up to share facts about one another, followed by Pass the Potato, which promoted teamwork and coordination. Later, students were shown pictorial drawings to build observation and imaginative skills, and finally, they played the Tiger and Cow game that emphasised protection, strategy, and group coordination. The students were enthusiastic and cooperative throughout the activities. The program helped in developing communication, creativity, and teamwork skills among the students. The committee plans to continue organising such programs in the future.



## **Workshop on the judgement: “In Re Article 370 of the Constitution” 6 January 2024**

**Venue:** 409, Central Block

**No. of Participants:** 25

The discussion focused on the abrogation of Article 370, examining its historical context, legal validity, and constitutional implications. Initially intended to accommodate Jammu and Kashmir's unique needs, Article 370 symbolised federal balance within India. However, the 2019 abrogation was critiqued for procedural flaws, as it bypassed constitutional mandates following the dissolution of the Jammu and Kashmir Constituent Assembly in 1956. Participants analysed the Constitutional Orders, particularly CO 273, for sidestepping ratification and violating Article 3 of the Indian Constitution. The conversation questioned the constitutional legitimacy of reorganising Jammu and Kashmir into Union Territories, arguing that such actions endangered India's federal structure. The session concluded that the abrogation lacked constitutional soundness, emphasising the importance of adherence to due process. The committee resolved to organise further workshops and thought-provoking discussions on emerging constitutional and political issues.

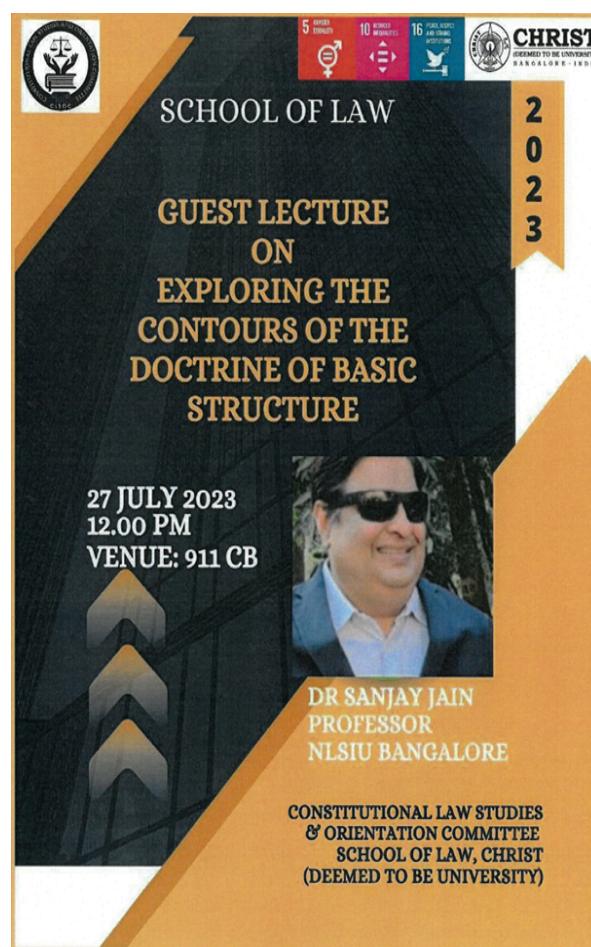
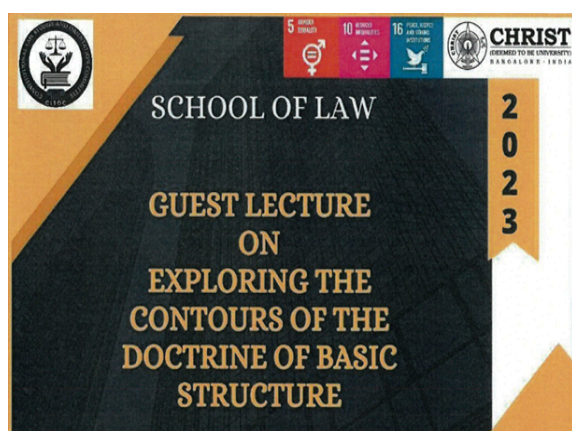


## **Exploring the contours of the doctrine of Basic Structure** **27 July 2023**

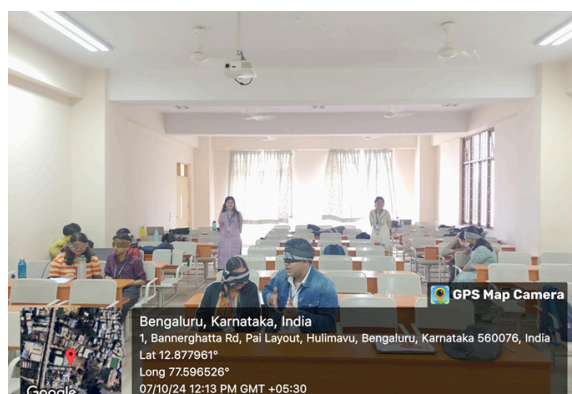


### Behind the Folds 7 October 2024

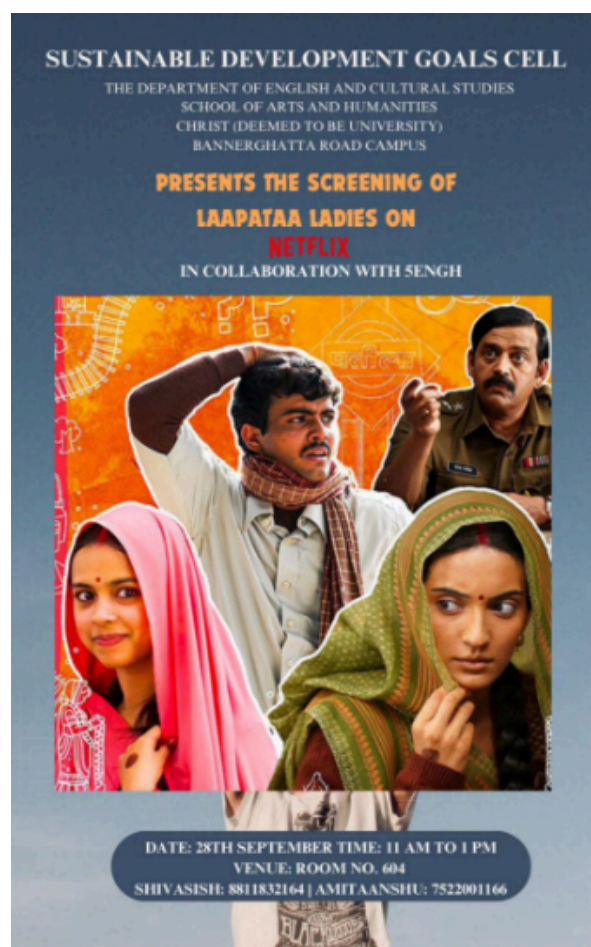


### Laapataa Ladies 28 September, 2024

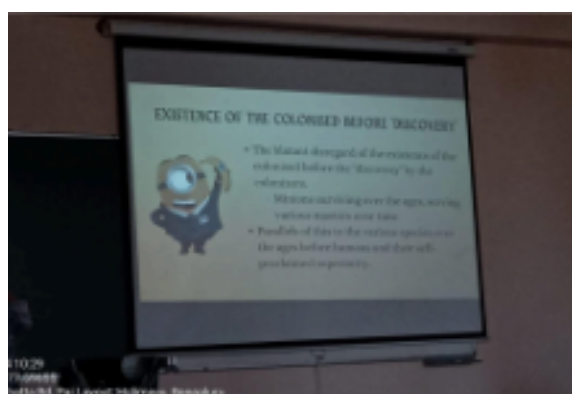


### Can The Minions Speak? 1 October 2024

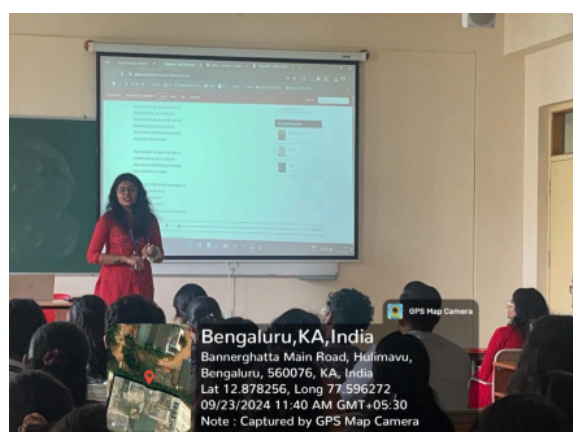


## **Kobita: Poetries in Translations** **23 September 2024**

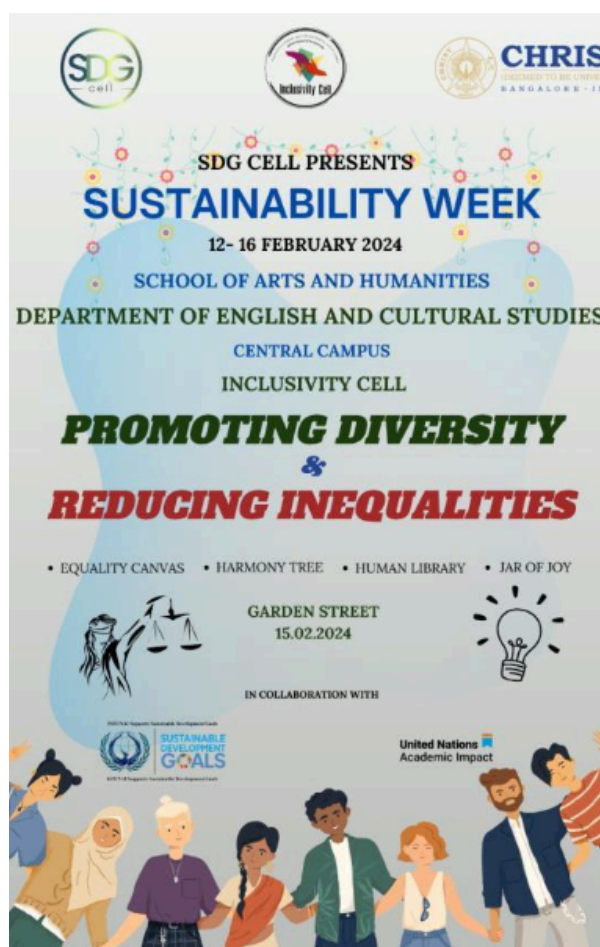

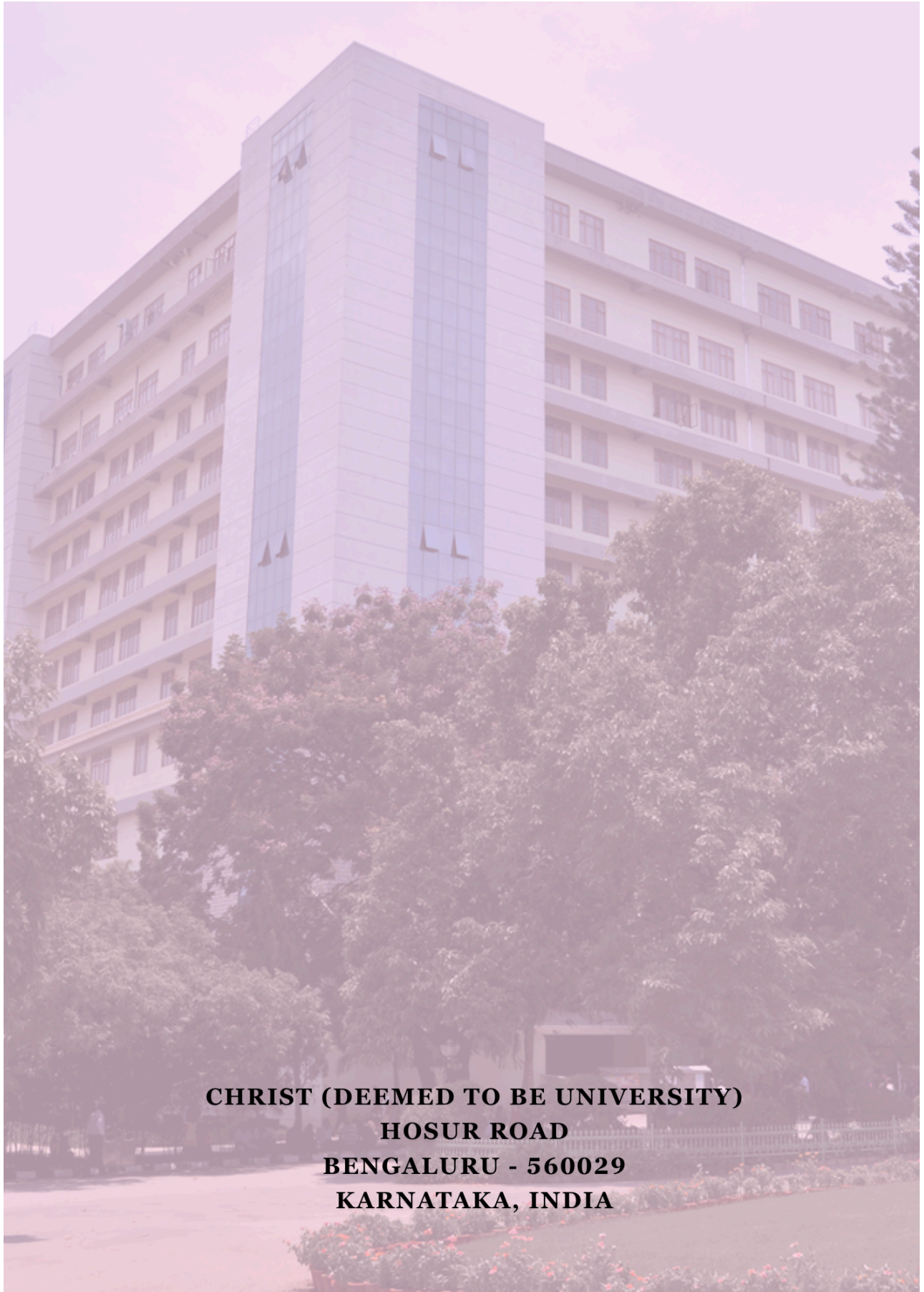
